ADMINISTRATIVELY CHARGED FEES 3/2000

EXPLANATORY STATEMENT

The administrative fees proposed are based upon the recovery of costs of the work performed in accordance with Government policy (Office of Financial Management Memo 1998/57 refers). Only the Heavy Vehicle Driver's Logbook, the Load Restraint Guide and the prepaid parking tickets have been increased by the consumer price index (CPI) of 2.5% and rounded for administrative convenience. They are not levied pursuant to requirements of any legislation and therefore do not require formal determination by the Minister, but are included for information and approval. All charges are notified in the ACT Government Gazette.

Set out below for easy reference are the new fees (and previous fees) which apply to saleable items. All items attract the Goods and Services Tax of 10% which is included in the fees shown in the last column.
