DRAFT VARIATION NO.176 TO THE TERRITORY PLAN FOR

**BRUCE CENTRAL PRECINCT (FERN HILL)
SECTIONS 5, 15, 32, 34, 75, SECTION 85 BLOCK 2 AND SECTION 33 BLOCK 2**

A draft Variation to the Territory Plan has been prepared by the Planning and Land Management Group (PALM) of Urban Services (incorporating the functions of the ACT Planning Authority), relating to the Bruce Central Precinct.

Draft Variation No.176 proposes to amend the Territory Plan to incorporate the following land use policies:

- about 20 hectares of Residential land with a new B14 area Specific Policy Overlay allowing for medium density housing up to 3 storeys in height;
- about 30 hectares of Commercial E (Office Sites) land with an expanded range of uses including Residential, Club and Hotel and provision for landmark buildings up to 5 storeys in height; and,
- at least 4 hectares of Urban Open Space in two hilltop parks which connect with pedestrian and cycle routes through and outside the precinct.

The draft Variation proposes to identify the area as Defined Land in accordance with the provisions of the Land Act. The Territory Plan Map will be amended to add the Defined Land overlay to the site. Section 7(3)(e) of the Land Act states that where the Territory Plan identifies land as Defined Land, it shall also set the principles and policies for its development. The Defined Land process will enable the Territory Plan to be progressively updated as the detailed designs for the area unfold.

Provided it is not deferred, the provisions of draft Variation No.176 have interim effect until 10 May 2002 or for the "defined period", whichever is the shorter. The "defined period" commenced on 11 May 2001 and continues until the proposals in the draft Variation, or the corresponding Plan Variation:

- come into effect;
- or are rejected by the Legislative Assembly;
- or are withdrawn.

During the period these provisions have interim effect, the Territory, the Executive, a Minister or a Territory Authority shall not do, or approve the doing of, any act which would be inconsistent with the Territory Plan, or the Plan if it was varied in accordance with the provisions of the draft Variation.

Section 11 of the *Land (Planning and Environment) Act 1991* (the Land Act), concerning the Heritage Places Register, does not apply to this proposal.
