Explanatory Note

The ICRC is required to have regard to the extent of the costs set out in Table 1 when determining annual licence fees, and to the relative scope and nature of the utility services provided by a utility set out in Table 2. Table 1 sets out the expected costs in relation to the licensee of the performance of functions under the Act and regulations of the ICRC, of the ESCC and of DUS's costs of technical regulation under Part 5 of the Act on behalf of the Territory. The Annual Licence Fee determined is the sum of 100% of these expected costs relating to the licensee in respect of the utility services as set out in Table 1. The ICRC's functions under the Act in respect of utilities are funded solely from annual licence fees. There is no budget allocation to the Department for its responsibilities in respect of technical regulation or for the ESCC. The ICRC has therefore determined that the ESCC's and Territory's costs (through DUS) also be recovered through licence fees.

AUSTRALIAN CAPITAL TERRITORY***UTILITIES ACT 2000*****GRANT OF LICENCE****EXPLANATORY STATEMENT**

The *Utilities Act 2000* (the "Act") requires persons providing electricity, gas, water and sewerage services in the ACT to hold an appropriate operating licence. The Independent Competition and Regulatory Commission (the "Commission") is responsible for issuing licences under the Act.

Section 37 of the Act requires the Commission to be satisfied before granting a licence that a person has the capacity to comply with the licence conditions and to operate a viable business as a licensee. Applicants must also satisfy any other requirements relevant to the Commission's objects under the Act. The objects of particular relevance are:

- encouragement of the provision of safe, reliable, efficient and high quality utility services at reasonable prices;
- promotion of ecologically sustainable development in the provision of utility services; and
- protection of consumers' interests.

The Commission has assessed the application for a licence made by AGL Electricity Ltd as meeting the necessary technical, prudential and other assessment criteria to provide electricity supply services. A licence has been granted accordingly.

Environmental Impact Assessment

The Environment Minister, under section 121 of the Land (Planning and Environment) Act 1991 (the Land Act), has directed that further Environmental Impact Assessment be made for the proposed ACT Prison on Blocks 8, 9 and 10 Section 102 Symonston.

The proponent has been nominated as Mr Michael Ockwell of the ACT Prison Project Office, FAI House, London Circuit, Canberra ACT 2601.

Under section 123 of the Land (Planning and Environment) Act 1991 this further assessment:

- 1) is to be in the form of a Public Environment Report:
- 2) is to address the following matters:
 - a) a complete assessment of the long and short term environmental impacts on flora and fauna, and other natural site features including water flows (quality and quantity) and including management of any impacts;
 - b) a complete assessment of the on-site and off-site visual impacts of locating the proposed prison on the nominated footprint;
 - c) a complete assessment of the on-site and off-site lighting impacts including the design and location of any light;
 - d) a complete assessment of the impacts of the proposed prison on 'Callum Brae'; and
 - e) review the appropriateness of accommodating the proposed prison on the Symonston site by taking into account the full assessment of all the known constraints and infrastructure requirements in respect to (a) – (d) above.
- 3) is to be submitted in draft form for public consultation in accordance with the Environment Minister's direction of 4 September 2001 under Section 124(1) of the Land Act; and
- 4) is to be revised taking into account all the comments received and submitted as a final PER to the Environment Minister in accordance with Section 127 of the Land Act.

CITY PART SECTIONS 35 AND 56 AND STRATUM BLOCK 1 SECTION 78**

**PROPOSED COMMERCIAL B2A CIVIC CENTRE LAND USE POLICY (PRECINCT b1),
PROPOSED COMMUNITY FACILITY SITES AND OTHER MINOR CHANGES**

Draft Variation to the Territory Plan No.189, has been prepared by the Planning and Land Management Group (PALM) of Urban Services (incorporating the functions of the ACT Planning Authority).

This draft Variation proposes to:

- vary the Territory Plan to remove the Community Facility Land Use Policy on Blocks 23 and 24 Section 35, a stratum Block 1 Section 78 and part of Block 11 Section 56 City and replace it with a Commercial B2A Civic Centre Land Use Policy;
- amend the precinct boundary delineating the extent of the Precinct b1- Business Area. Currently the Griffin Centre and Civic Youth Centre are located on this area with the skateboard park nearby;
- remove the existing Commercial B2A Civic Centre Land Use Policy from parts of Section 56 and replace it with a Community Facility Land Use Policy. These policy changes will facilitate the redevelopment of this part of the City and ensure that the new community facility sites are made subject to the Community Facility Land Use Policies in the Territory Plan; and
- delete the existing Major Road Land Use Policy, applying to parts of Ballumbir Street and Cooyong Street adjoining the proposed development site, and substitute the Community Facility Land Use Policy and Commercial (B2A) Land Use Policy, Precinct B1 (Business Area) respectively. These changes are proposed to accommodate the new Youth Centre and the development on parts of Section 35 & 56 City.

Provided it is not deferred, the provisions of draft Variation No.189 have interim effect until 10 September 2002, or for the "defined period", whichever is the shorter. The "defined period" commenced on 11 September 2001 and continues until the proposals in the draft Variation, or the corresponding Plan Variation:

- come into effect;
- or are rejected by the Legislative Assembly;
- or are withdrawn.

During the period these provisions have interim effect, the Territory, the Executive, a Minister or a Territory Authority shall not do, or approve the doing of, any act which would be inconsistent with the Territory Plan, or the Plan if it was varied in accordance with the provisions of the draft Variation.

Section 11 of the *Land (Planning and Environment) Act 1991* (the Land Act), concerning the Heritage Places Register, does not apply to this proposal.
