NOTICE OF COURSE AND COURSE PROVIDERS

ACCREDITATION TRAINING COURSE FOR DRIVING INSTRUCTORS

This is the Schedule to the instrument of approval of the Course for the instruction of persons who wish to become driving instructors known as the 'Accreditation Training Course For Driving Instructors', and for the Course Providers.

The course of instruction deals with those matters referred to hereunder:

Pre-requisite Written and Practical Tests

Prior to commencing the accreditation course, candidates are required to successfully complete an assessment of competency in the following pre-requisite modules:

Module NRT 206 Road Law Understanding
Module NRT 210 Safe and Efficient Car Driving

Successful completion of the pre-requisite modules requires:

1. A pass mark of seventy five percent (75%) for Module NRT 206; and
2. A pass mark of eighty five percent (85%) for each of the two parts of Module NRT 210.

1. Applicants to demonstrate they are competent in each of the accreditation course modules as determined by the course instructors; and
2. Being awarded a 'Statement of Attainment' provided by the Course Provider attesting to the completion of the above matters.
