Road Transport (General) Act 1999, section 54(1)(b) – Delegation of administering authority's functions

1. Name of Instrument

This instrument is the Road Transport (General) (Administering Authority) Delegation 2008 (No 1).

2. Commencement

This instrument commences on the day after its notification day.

3. Defined terms

The dictionary in section 7 provides definitions for this instrument.

4. Delegation of functions – parking related offences

(1) I delegate all my functions under Part 3 of the *Road Transport (General) Act* 1999 and section 11 of the *Road Transport (Offences) Regulation 2005* to each person who occupies a position listed in column 1 of table 1 of the Schedule.

Note: The *Legislation Act 2001* defines 'occupy' in relation to a position to include hold the position, act in the position or exercise functions of the position.

- (2) In respect of each item in the table 2 of the Schedule, I delegate the function listed in column 1 of that item to each person who occupies a position listed in column 3 of that item.
 - *Note 1* Section 15 of the *Road Transport (Offences) Regulation 2005* permits the administering authority to delegate their infringement notice offence functions to a public employee.
 - *Note 2* The *Legislation Act 2001* defines 'occupy' in relation to a position to include hold the position, act in the position or exercise functions of the position.

(3) The delegations in table 1 and table 2 of the Schedule are limited to matters relating to the infringement notice offences referred to in paragraphs 8(a) and 8(f) of the *Road Transport (Offences) Regulation 2005*.

5. Delegation of functions – other road transport related offences

- (1) I delegate all my functions under Part 3 of the *Road Transport (General) Act* 1999 and section 11 of the *Road Transport (Offences) Regulation 2005* to each person who occupies a position listed in column 1 of table 3 of the Schedule.
 - *Note:* The *Legislation Act 2001* defines 'occupy' in relation to a position to include hold the position, act in the position or exercise functions of the position.
- (2) In respect of each item in the table 4 of the Schedule, I delegate the function listed in column 1 of that item to each person who occupies a position listed in column 3 of that item.
 - *Note 1* Section 15 of the *Road Transport (Offences) Regulation 2005* permits the administering authority to delegate their infringement notice offence functions to a public employee.
 - *Note 2* The *Legislation Act 2001* defines 'occupy' in relation to a position to include hold the position, act in the position or exercise functions of the position.
- (3) The delegations in table 3 and table 4 of the Schedule are limited to matters relating to the infringement notice offences referred to in paragraphs 8(b), 8(d) and 8(e) of the *Road Transport (Offences) Regulation 2005*.
