SDN Children's Services Inc. was issued a Compliance Notice regarding non compliance with the following Standards:

Standard 1.39

In childcare centres, there must be sufficient primary contact staff deployed throughout the premises to ensure that no child is left without adequate supervision.

Standard 2.64

Where the premises are adjacent to any hazard, the perimeter fence must be at least 1500mm high.

Standard 2.65

Fences must be designed to prevent children from climbing over or crawling under them.

SDN Children's Services Inc. responded to the Compliance Notice as directed. The Compliance Notice was confirmed.

Proprietor Submission in response to the Childcare Standards Report Notice :

Thank you for the opportunity to respond to the Childcare Standards Report Notice detailed in your letter dated 7 August 2009.

We understand that the Chief Executive proposes to include information in the Childcare Standards Report about the Compliance Notice sent to SDN Children's Services with regard to non compliance at SDN Bluebell Early Childhood Education Centre, 44 College Street, Belconnen, ACT on 22 May 2009.

SDN Children's Services takes any non compliance with the ACT Childcare Services Standards 2009 extremely seriously. We welcome the opportunity to respond as follows:

Standard 1.39

SDN Bluebell's records and documentation on Friday 22 May 2009 demonstrate clearly that we had the required primary contact staff on the premises as required by the Childcare Services Standard. This did not prevent the child in question leaving the centre without the knowledge of staff.

Standard 2.64 and Standard 2.65

SDN acknowledges that as noted in the Notice to Enforce Requirements, the fence was non compliant with Standard 2.64. Subsequent to the Notice to Enforce Requirements, SDN Children's Services has replaced the entire fence perimeter to 1500mm, to ensure compliance with Standard 2.64 and Standard 2.65. We note that the fence had historically been deemed compliant, and was never identified as a risk in the scheduled and regulatory monitoring visits, carried out by the Children's Policy and Regulation Unit previous to this occasion.
