Trespass on Territory Land Act 1932, s 3A (Inspectors)

1 Name of instrument

This instrument is the Trespass on Territory Land (Inspectors) Appointment 2010 (No 1).

2 Commencement

This instrument commences on the day after it is notified.

3 Appointment of inspectors

I appoint the people who from time to time occupy the public service positions listed in the Schedule as inspectors.

Note 1 The *Legislation Act 2001* defines ‘occupy’, in relation to a position, to include hold the position, act in the position or exercise functions of the position.

Note 2 Section 3A of the *Trespass on Territory Land Act 1932* requires inspectors to be public servants. The *Legislation Act 2001* defines ‘public servant’ to mean a person employed in the Australian Capital Territory Public Service.

4 Revocation of prior appointments

This instrument revokes instruments NI2008—262 and NI2008—525.
