

Domestic Animals (Registrar, Deputy Registrars and Authorised Officers) Appointment 2012 (No 1)

1 Name of instrument

This instrument is the Domestic Animals (Registrar, Deputy Registrars and Authorised Officers) Appointment 2012 (No 1).

2 Commencement

This instrument commences on the day after its notification day.

3 Appointment of registrar

I appoint the person who from time to time occupies the position listed in column 2 of table 1 of the schedule as the registrar.

4 Appointment of deputy registrars

I appoint each person who, from time to time occupies a position listed in column 2 of table 2 of the schedule as a deputy registrar.

Note 2. In particular a person may be appointed for a particular provision of a law (see Legislation Act s7(3)) and an appointment may be made by naming a person or nominating the occupant of a position (see s 207)

5 Appointment of authorised officers

I appoint each person who, from time to time occupies a position listed in column 2 of table 3 of the schedule as an authorised officer.

Note For the making of appointments including acting appointments see the Legislation Act Pt 19.3

Note 2. In particular a person may be appointed for a particular provision of a law (see Legislation Act s7(3)) and an appointment may be made by naming a person or nominating the occupant of a position (see s 207)
