1 Name of instrument

This instrument is the *Public Sector Management (Heritage) Delegation 2014 (No 1)*.

2 Commencement

This instrument commences on the day after notification.

3 Subdelegation of Heritage Act functions

Under section 36C of the *Public Sector Management Act 1994*, I subdelegate to the person who from time to time occupies a public service position identified in column 3 of table 1 of the attached schedule, the corresponding functions set out in column 1 of the table.

Note 1: The Legislation Act 2001 defines “occupy”, in relation to a position, as including: to hold the position, act in the position or exercise functions of the position.

Note 2: Under section 121 of the Heritage Act 2004, the Heritage Council has delegated to the Director-General with administrative responsibility for the Heritage Act the functions set out in column 1 of table 1 of the attached schedule, refer to Heritage (Heritage Council) Delegation 2011 (No 1), NI2011-270.

4 Delegation of Heritage Act function

Under section 36C of the *Public Sector Management Act 1994*, I delegate to the person who from time to time occupies the public service position identified in column 3 of table 2 of the attached schedule, the corresponding function set out in column 1 of the table.

5 Revocation

All previous subdelegations of *Heritage Act 2004* functions made under section 36C of the *Public Sector Management Act 1994* are revoked.
