

# Planning and Development (EIS Exemption Application – OneSun Capital Solar Farm at Williamsdale) Consultation Extension 2015 (No 1)\*

## **1 Name of instrument**

This instrument is the *Planning and Development (EIS Exemption Application – OneSun Capital Solar Farm at Williamsdale) Consultation Extension 2015 (No 1)*.

## **2 Commencement**

This instrument commences on the day after its notification.

## **3 Public consultation period extension**

Under s211D(2) of the *Planning and Development Act 2007* (the Act), I extend the public consultation period established under the *Planning and Development (EIS Exemption Application – OneSun Capital Solar Farm at Williamsdale) Consultation Notice 2015 (No 1)*, NI2015-184 (original consultation notice), to 2 June 2015.

## **4 Making of submissions**

Anyone may give a written submission to the Chief Planning Executive (delegate) about the EIS exemption application notified under the original consultation notice. Submissions may be given only during the consultation period or period as extended.
