### Utilities (Annual Licence Fees Determination 2015-16) Variation Notice 2015

#### Notifiable Instrument NI2015-692

made under the

*Utilities Act* 2000, s 52 (Public notice of licence decisions) (see also s 45 (Determination of fee) and s 53 (Public access to licences etc))

#### 1 Name of instrument

This instrument is the *Utilities (Annual Licence Fees Determination 2015-16) Variation Notice 2015.* 

#### 2 Commencement

This instrument commences on the day after it is notified.

#### 3 Variation of 2015-16 Annual Licence Fee Determination

The Independent Competition and Regulatory Commission (Commission) has varied the Annual Utilities Licence Fees Determination 2015-16 as notified by the Commission on 23 September 2015 (NI2015-563). The variation being made is to the estimated costs for 2015-16 for the Commission for the regulation of Icon Water. The new estimation is \$603,438 (previously estimated at \$133,000).

The result of the variation in estimated costs for the Commission is an increase in Icon Water's licence fee for 2015-16 from \$870,546.96 to \$1,340,984.96. The variation and resulting change to total figures and Icon Water's licence fee are outlined (highlighted) below in the tables in the schedule to this instrument. The explanation for the variation is set out in the explanatory statement to this instrument. All other costs and licence fees remain as notified in NI2015-563.

#### 4 Regulatory costs and derivation of licence fees

The Commission has set out in the schedule to this notice the tables as set out in the schedule to NI2015-563 with updated figures (highlighted) resulting from the variation. Note that figures in the tables may not add up due to rounding.

Tables 1 sets out the licence fees for 2015-16 payable by:

- East Australian Pipeline Limited (licensed to supply gas transmission services);
- Icon Water Limited (licensed to supply water and sewerage services); and
- TransGrid (licensed to provide electricity transmission services).

Table 2 sets out the derivation of the licence fees payable including the adjustment for the difference between the total estimated regulatory costs for 2014-15 and the total actual regulatory costs for 2014-15.

In determining the licence fee payable by each utility, the Commission had regard to:

- what it considered the utilities should make as a reasonable contribution towards the costs incurred or expected to be incurred by the three regulators;
- the amount of the fee and the way it is worked out; and
- the relative scope and nature of the services provided by all utilities.

Tables 3-5 set out the total regulatory costs for the three ACT government utility regulators used in the derivation of the annual licence fees, namely:

- the Commission;
- the ACT Civil and Administrative Tribunal; and
- the technical regulator.

#### 5 Public access to determination of annual licence fees
