1 Name of Instrument

This instrument is the *Road Transport (General) (Infringement Notice Offences) Delegation 2016 (No 1)*.

2 Commencement

This instrument commences on 6 July 2016.

3 Defined terms

4 Delegation of functions – parking related offences

- (1) I delegate each function identified in column 1 in schedule 1 to the person from time to time occupying or performing the duties of the position identified in column 3 of the same row in schedule 1.
- (2) The delegations in schedule 1 are limited to matters relating to the infringement notice offences mentioned in section 8 (1)(a) and 8(1)(b) of the *Road Transport (Offences) Regulation 2005*.
