1 Name of instrument

This instrument is the Lakes (Delegate and Inspectors) Appointment 2016 (No 1).

2 Commencement

This instrument commences on the day after it is notified.

3 Delegate for Lakes

I appoint the person occupying the public service position P15181 as the Delegate for Lakes.

- Note 1 The Head of Access Canberra is authorised to exercise functions of the Directors General under the Territory laws that have been declared by the Chief Minister: se s37A of the Public Sector Management Act 1994.
- Note 2: The power to appoint the Delegate for Lakes and Inspectors was declared under s37A in NI2015-714, Public Sector Management (Head of Access Canberra Functions) Declaration 2015.
- Note 3 At the time of making this instrument, the Head of Access Canberra is Deputy Director-General, Access Canberra.

4 Appointment of Inspectors

I appoint the people who occupy the public service positions listed in table 1, table 2, table 3 and table 4 within schedule 1 as inspectors.

- Note 1 The Legislation Act 2001 defines 'occupy', in relation to a position, to include hold the position, act in the position or exercise functions of the position.
- Note 2 Section 7(1) of the *Lakes Act 1976* requires inspectors to be public servants. The *Legislation Act 2001* defines 'public servant' to mean a person employed in the Australian Capital Territory Public Service.
- Note 3 Section 7(2) of the Lakes Act 1976 states that the delegate for lakes and police officers are also inspectors
