1 Name of instrument

This instrument is the *Nature Conservation (Conservator) Delegation 2016 (No 2)*.

2 Commencement

3 Delegation of conservator's functions

I delegate the functions of the Conservator of Flora and Fauna under the provisions of the *Nature and Conservation Act 2014* specified in column 1 of the schedule to the conservation officer who from time to time occupies the position specified in the corresponding entry in column 2 of the schedule.

Note The Legislation Act defines 'occupy' a position to include hold the position, act in the position or exercise functions of the position.

4 Revocation

The *Nature Conservation (Conservator) Delegation 2015 (No 1)* (NI2015-298) and *Nature Conservation (Conservator) Delegation 2016* (NI2016-510) are revoked.
