1 Name of Instrument

This instrument is the *Planning and Development (Land Development Agency) Delegation* 2017 (No 1).

2 Commencement

This instrument commences on the day after it is signed.

3 Delegation of Functions

I delegate the functions of the planning and land authority, delegated to the Land Development Agency on 31 March 2008, under the provisions of the *Planning and Development Act 2007* section 20, identified in column 2 of the Schedule to the persons who from time to time occupy the positions as a land agency staff member identified in the corresponding entry in column 3.

Note

The Legislation Act 2001 defines "occupy", in relation to a position, as including: to hold the position, act in the position or exercise functions of the position.

4 Limitation on Functions

The function may only be exercised if:

- a. the Land Development Agency has satisfied itself that the lease may be lawfully granted; and
- b. (i) the form of the lease is in accordance with a registered Memorandum of provisions and in a standard format that has been approved by the Planning and Land Authority; or
 - (ii) the form of the lease to be used has been approved by the Planning and Land Authority, and the Authority has provided written advice to the Land Development Agency of its approval. The approval of the Authority for use of such lease format will remain in place until the Agency is advised that form of lease has ceased to be approved for use.

5 Revocation

This instrument revokes the *Delegation Land Development Agency* made on the 30 June 2016.
