### **1 Name of instrument**

This instrument is the *Victims of Crime (Victims Advisory Board – Government Members) Appointment 2017 (No 1)*.

### **2 Commencement**

This instrument commences on the day after it is notified.

### **3 Appointment – ACT Corrective Services member**

I appoint the EXECUTIVE DIRECTOR OF ACT CORRECTIVE SERVICES as the ACT Corrective Services member of the Victims Advisory Board for the period of three years commencing on the day after this instrument is notified.

### **4 Appointment – Australian Federal Police member**

I appoint the DEPUTY CHIEF POLICE OFFICER (CRIME), ACT POLICING as the Australian Federal Police member of the Victims Advisory Board for the period of three years commencing on the day after this instrument is notified.

### **5 Appointment – ACT Director of Public Prosecutions member**

I appoint the DEPUTY DIRECTOR OF THE OFFICE OF THE ACT DIRECTOR OF PUBLIC PROSECUTIONS as the ACT Director of Public Prosecutions member of the Victims Advisory Board for the period of three years commencing on the day after this instrument is notified.

## **6 Appointment – ACT Restorative Justice member**

I appoint the MANAGER OF THE ACT RESTORATIVE JUSTICE UNIT as the ACT Restorative Justice member of the Victims Advisory Board for the period of three years commencing on the day after this instrument is notified.

## **7 Appointment – ACT Youth Justice member**

I appoint the SENIOR DIRECTOR, ACT CHILD AND YOUTH PROTECTION SERVICES as the ACT Youth Justice member of the Victims Advisory Board for the period of three years commencing on the day after this instrument is notified.

## **8 Revocation**
