STATEMENT OF PURPOSE

To provide instructions to staff operating the x-ray entry point at the Alexander Maconochie Centre (AMC).

PROCEDURES

1. Entry Through the Gatehouse

- 1.1. All persons must remove and place the following items through the X-Ray (in plastic trays provided):
 - Bags
 - Wallets and coins
 - Watches, keys and glasses
 - Shoes, belts and jackets
 - Lanyards and passes
 - Pens and diaries
 - Medical pouches
 - Authorised electronic devices and training material
 - Food and drink containers and/or packaging
 - Any other items in pockets.
- 1.2. Visitors and staff must then proceed through the rotating metal detector.
- 1.3. If prohibited item/s are detected, contact the Area Supervisor.
- 1.4. The Area Supervisor must attend and witness the search of all personal property.
- 1.5. Prohibited items must be seized and the Officer in Charge (OIC) notified.
- 1.6. Approval for electronic devices must be confirmed using the exemption <u>register</u>, and the item logged in the register.
- 1.7. All persons must proceed to the iris scanning point to access the centre.
- 1.8. If the iris scan does not permit entry, the person must be redirected to Visits Reception to check iris status and re-enter through the above procedure.

2. Unable to Progress Through the Metal Detector

- 2.1 Notify the Area Supervisor via radio.
- 2.2 Ensure the person and their belongings remain on the external side of the X-ray point.
- 2.3 The Area Supervisor, or delegate, must attend and conduct a hand held metal detector scan of the person.
- 2.4 The scan must be logged in the manual search register.

- 2.5 If prohibited item/s are located, immediately notify the OIC and follow the relevant Operating Procedure to seize any prohibited items.
- 2.6 If no prohibited items are detected, contact the OIC to request metal detector bypass.
- 2.7 With OIC approval, radio the MCR to request access through Door 1.
- 2.8 The person will enter via Door 1, and their personal belongings will be X-rayed.

3. Medical Exemptions

- 3.1 A person with a medical exemption may advise the X-Ray Officer of the exemption upon arrival at the X-ray entry point.
- 3.2 Confirm details in the <u>medical exemptions register</u> and radio the MCR to request that door 1 be opened.
- 3.3 If unable to confirm exemption, contact the OIC.
