1 Name of instrument

This instrument is the *Environment Protection (Authority and Authorised Officers) Appointment 2017 (No 1)*.

2 Commencement

This instrument commences on 1 January 2018.

3 Appointment of Environment Protection Authority

I appoint the person who from time to time occupies the public servant position number P39139 as the Environment Protection Authority.

Note 1: The Head of Access Canberra is authorised to exercise functions of the Directors General under the Territory laws that have been declared by the responsible Minister: see section 21 of the Public Sector Management Act 1994.

Note 2: The power to appoint the Environment Protection Authority and Authorised Officers was declared under section 21 in NI2017-465, Public Sector Management (Head of Access Canberra Functions) Declaration 2017.

Note 3: At the time of making this instrument, the Head of Access Canberra is Deputy Director-General, Access Canberra.
