

## **Children and Young People (Prohibited Things) Declaration 2018 (No.1)**

**Notifiable instrument NI2018-444**

made under the

***Children and Young People Act 2008, Section 148 Prohibited things***

### **1 Name of instrument**

This instrument is the *Children and Young People (Prohibited Things) Declaration 2018 (No.1)*.

### **2 Commencement**

This instrument is to commence the day after notification.

### **3. Repeal**

NI2015-393 is revoked

### **4 Declaration of prohibited things**

Under section 148 of the Children and Young People Act 2008, I declare the following things to be prohibited things at a detention place on the basis that the declaration is necessary or prudent to ensure security or good order at a detention place:

- (a) Cigarettes, cigarette papers, pipes and tobacco
- (b) Alcohol, drugs or associated paraphernalia
- (c) Lighters, matches and flints
- (d) Weapons or firearms
- (e) Non Issued keys
- (f) Money, credit cards or bankcards
- (g) Pornography or material containing adult, criminal or offensive content
- (h) any part of a thing mentioned above.

### **5 Declaration of prohibited things subject to exceptions**

I declare the following things to be prohibited things at a detention place, subject to the exceptions outlined below, on the basis that the declaration is necessary or prudent to ensure security or good order at a detention place:

- (a) Prescription and non-prescription medication, other than prescription and non-prescription medication that the Manager has approved to be taken by a young detainee
- (b) Tools and related equipment, other than at times designated as program times or for a specific program or as approved by the Manager for another lawful purpose

- (c) Razor blades, knives or anything that can be used to cut, other than at meal times or as authorised by the Manager for another lawful purpose
- (d) Food stuffs, other than at meal times or as approved by the Manager;
- (e) Prams and bassinets, other than those required for specific needs as approved by the Manager
- (f) Toiletry products other than those issued or approved for issue by the Manager
  - i. grooming products other than those issued or approved for issue by the Director, Bimberi
  - ii. needles, syringes or other sharps except those required for specific needs as approved by the Manager
- (g) Cameras unless approved by the Manager for a specific purpose;
- (h) Handbags, backpacks or bags of any kind unless approved by the Manager
- (i) Petrol, thinners or propellants of any kind unless approved by the Manager for a lawful purpose
- (j) Glues or aerosols other than at times designated as program times or for a specific program or as approved by the Manager for another lawful purpose
- (k) Mirrors, glass, ceramics of any kind other than at times designated as program times or for a specific program or as approved by the Manager for another lawful purpose
- (l) Jewelry unless approved by the Manager
- (m) Cosmetics of any kind unless required for specific needs or programs as approved by the Manager
- (n) Wire, rope or cord of any kind other than at times designated as program times or for a specific program or approved by the Manager for another lawful purpose
- (o) Mobile phones, smart electronic wearables including smart watches, portable electronic equipment other than at times designated as program times or for a specific program or approved by the Manager for another lawful purpose
- (p) Personal possessions unless approved by the Manager.
