1 Name of instrument

This instrument is the *Environment Protection (Authorised Officers) Appointment 2019 (No 1)*.

2 Commencement

This instrument commences on the day after it is notified.

3 Appointment of authorised officers

I appoint the persons occupying the public service positions identified in table 1 and table 2 of schedule 1 as authorised officers for the *Environment Protection Act 1997*.

Note 1: The Head of Access Canberra is authorised to exercise functions of the Directors-General under the Territory laws that have been declared by the responsible Minister: see section 21 of the Public Sector Management Act 1994.

Note 2: The power to appoint a public servant as an authorised officer was declared a declared function pursuant to section 21 of the Public Sector Management Act 1994 in NI2017-465, Public Sector Management (Head of Access Canberra Functions) Declaration 2017.
