

Financial Management (Unclaimed Trust Money—Rental Bonds) Statement 2019 (No 2)

Financial Management Act 1996, s 53A (Unclaimed trust money)

1 Name of instrument

This instrument is the *Financial Management (Unclaimed Trust Money—Rental Bonds) Statement 2019 (No 2)*.

2 Commencement

This instrument commences on the day after its notification day.

3 Unclaimed trust money

- (1) In accordance with section 53A of the *Financial Management Act 1996*, schedule 1 sets out, in relation to all unclaimed trust money held in the trust banking account with this directorate as at 1 January 2017, the following details:

- (a) the name, and last-known address, of each person entitled to the unclaimed trust money held in the account; and
- (b) the amount of the trust money to which each person is entitled.

The total amount of unclaimed trust money as at 1 January 2017 is \$59,285.49.

- (2) In accordance with section 53A of the *Financial Management Act 1996*, schedule 2 sets out, in relation to all unclaimed trust money held in the trust banking account with this directorate as at 1 January 2018, the following details:

- (a) the name, and last-known address, of each person entitled to the unclaimed trust money held in the account; and
- (b) the amount of the trust money to which each person is entitled.

The total amount of unclaimed trust money as at 1 January 2018 is \$99,189.50.

Note 1 For these statements, money held in a trust banking account is unclaimed trust money if not less than 6 years has elapsed since the date the money became payable, and during that period, no-one entitled to the money has requested that the money be paid to him or her or according to his or her direction.

Note 2 The total amount shown in these statements must be paid into the territory banking account when this statement is given to the Treasurer and, on being paid into that account, becomes public money of the Territory.

Note 3 A person who claims to be entitled to any money paid into the territory banking account may apply to the Treasurer for a payment of an amount equal to the money to which the person is entitled.

- (3) The authorised deposit-taking institution holding the unclaimed trust money is the Westpac Banking Corporation, BSB 032-777, a/c 002095.

4 Revocation

This instrument revokes *Financial Management (Unclaimed Trust Money—Rental Bonds) Statement 2018 (No 1) NI2018-30*.
