1 Name of instrument

This instrument is the *Environment Protection (Authority) Delegation 2020 (No 1)*.

2 Commencement

This instrument commences on the day after it is signed.

3 Delegation

- b) I delegate the functions of the Environment Protection Authority under the provision of the *Environment Protection Act 1997* identified in column 2 of schedule 2 to the persons occupying or performing the duties from time to time of the position classifications within the office of the Environment Protection Authority, Access Canberra specified in the corresponding row of column 4 of schedule 2.
