# Road Transport (General) Road Transport Authority Delegation 2021 (No 1)\*

### 1 Name of instrument

This instrument is the *Road Transport (General) Road Transport Authority Delegation 2021 (No 1)*.

## 2 Commencement

This instrument commences on the day after it is signed.

## 3 Delegation

- 1) I, Director-General of the Transport Canberra and City Services Directorate, in my capacity as a road transport authority, delegate those of my powers and functions under:
  - a) sections 19, 20, 45, 46, 47, 59, and 225 of the *Road Transport* (*General*) *Act 1999*;
  - b) sections 13AA, 14 (1), 14 (2) and 14 (3) of the *Road Transport* (*General*) *Regulation* 2000;
  - c) sections 36, 64 (except subsection (2) (g)), 65 and 66 of the *Road Transport (Safety and Traffic Management) Regulation 2017*; and
  - d) sections 17, 22, 23, 24, 26, 36, 43, 78B and 107 (4) of the *Road Transport Driver Licensing Regulation 2000*

#### to the:

- a) head of Access Canberra, and
- b) Executive Group Manager (position number E847), Access Canberra.

- 2) I, Director-General of the Transport Canberra and City Services Directorate, in my capacity as a road transport authority, delegate those of my powers and functions in the *Road Transport (General) Act 1999* specified in column 1 of schedule 1 to this instrument, to each person occupying or performing the duties, from time to time, of a position specified in the corresponding row of column 3 of schedule 1 of this instrument.
- 3) I, Director-General of the Transport Canberra and City Services Directorate, in my capacity as a road transport authority, delegate those of my powers and functions in the *Road Transport (Driver Licensing) Regulation* 2000 specified in column 1 of schedule 2 to this instrument, to each person occupying or performing the duties, from time to time, of a position specified in the corresponding row of column 3 of schedule 2 of this instrument.
- 4) I, Director-General of the Transport Canberra and City Services Directorate, in my capacity as a road transport authority, delegate those of my powers and functions in the *Road Transport (Public Passenger Services) Act 2001* specified in column 1 of schedule 3 to this instrument, to each person occupying or performing the duties, from time to time, of a position specified in the corresponding row of column 3 of schedule 3 of this instrument.
- 5) I, Director-General of the Transport Canberra and City Services Directorate, in my capacity as a road transport authority, delegate those of my powers and functions in the *Road Transport (Public Passenger Services) Regulation 2002* specified in column 1 of schedule 4 to this instrument, to each person occupying or performing the duties, from time to time, of a position specified in the corresponding row of column 3 of schedule 4 of this instrument.

Note: Section 17 (1) (b) of the *Road Transport (General) Act 1999* provides that the road transport authority can delegate a road transport authority's functions under the road transport legislation to a public employee.

Section 16 (3) of the *Road Transport (General) Act 1999* defines the road transport authority. This section in conjunction with the *Administrative Arrangements* determines which Director-General is the road transport authority for certain provisions of the road transport legislation.

## 4 Definitions

In this instrument:

Access Canberra, means the business unit known as Access Canberra.

*Executive Group Manager* means the public employee occupying, from time to time, position number E847, however described.

*head,* of Access Canberra, means the public employee occupying, from time to time, the position (however described) of head of Access Canberra.

*road transport legislation* – see section 6 of the *Road Transport (General) Act* 1999

## 5 Revocation

This instrument revokes the:

- 1) Road Transport (Driver Licensing) Delegation 2019 (No 1) NI2019-860; and
- 2) Road Transport (General) Delegation 2019 (No 1) NI2019-130.
