1 Name of instrument

This instrument is the *Road Transport (General) Transport Canberra Authorised People Appointment 2021 (No 1)*.

2 Commencement

This instrument commences on the day after it is signed.

3 Appointment

I appoint each of the persons specified in column 2 of schedule 1 to be an authorised person for the provisions of the road transport legislation specified in column 3 of schedule 2.

I am satisfied that each person appointed in schedule 1 to this instrument complies with the requirements in section 19 (3) of the *Road Transport (General) Act 1999*.

Note

The Road Transport (General) Delegation 2019 (No 1) (NI2019-130) delegates functions and powers under the Road Transport (General) Act 1999, for which the Director-General of the Justice and Community Safety Directorate is the relevant road transport authority, to specific public employees in the Transport Canberra and City Services Directorate.

5 Revocation

I revoke the instrument of appointment *Road Transport (General)Transport Canberra Authorised People Appointment 2019 (No 1)* dated 12 July 2019.
