### 1.0 INTRODUCTION

### 1.1 Outline of the process

Minor plan amendment 2024-e (MA2024-e) to the Territory Plan is a minor plan amendment (MA) prepared under section 84 2) d) of the *Planning Act 2023* (the Planning Act).

Section 84 of the Planning Act outlines the different types of MAs, some which require limited consultation to be undertaken and some which require no consultation to be undertaken.

Under Section 85 of the Planning Act a MA can only be made where:

- any required limited consultation has taken place, and the authority is satisfied that the content of the MA meets the requirements of the Planning Act
- if the MA is not inconsistent with the planning strategy or any relevant district strategy
- any comments received during the consultation period and from the National Capital Authority have been considered.

This MA required limited consultation to be undertaken and was released for limited public consultation in accordance with the *Planning Act 2023*.

The MA is not inconsistent with the planning strategy or any relevant district strategy. Further details of the changes are contained in section 3 of this document.

The National Capital Authority has received a copy of this MA.

### 1.2 Summary of the changes

MA2024-e makes the following changes:

• Amend the Inner North and City District Policy by adding a new policy outcome for the City Centre Entertainment Precinct and replace Figure 14 with a revised figure to show the frame and core areas in the precinct.

### 2.0 CONSULTATION WITH THE PUBLIC

### 2.1 Consultation period

Under section 84 (2) (c) of the *Planning Act 2023*, this minor amendment was subject to limited public consultation of at least 20 working days.

### 2.2 Comments from the public

Written comments were invited on MA2024-e from the public from 4 April 2024 until 3 May 2024.

No submissions were received.

The National Capital Authority has been advised of this minor amendment.

### 3.0 TERRITORY PLAN CHANGES

This section contains details of the changes made to the Territory Plan.

### 3.1 Inner North and City District Policy

Changes are being made to add an additional policy outcome for the City Centre Entertainment Precinct (CCEP), and the associated Figure 14 Is being replaced to show the new frame and core areas of the precinct.

An entertainment precinct is an area where existing and future nightlife character and activities, including live music, are prioritised. These precincts give greater certainty to patrons, businesses, residents, the night-time economy industry and building owners.

The City Centre Entertainment Precinct was introduced in the new Territory Plan (Inner North and City District Policy), which came into effect on 27 November 2023. This fulfilled a commitment of the Parliamentary and Governing Agreement (PaGA) of the 10<sup>th</sup> Legislative Assembly to amend the Territory Plan to create Entertainment Precincts, starting with a city entertainment precinct.

Noise is a key planning consideration in entertainment precincts. Live and amplified music within entertainment precincts typically include bass-heavy beats which travel farther than higher frequency noises. Low frequency (bass) noise also penetrates building facades more readily than high frequency noises, which can impact building occupants. To minimise the risk of harm to human health from noise, complementary reforms to other legislation are being undertaken.

Environmental noise, including noise from amplified music, is regulated under the *Environment Protection Regulation 2005*, made under the *Environment Protection Act 1997*. The ACT is divided into Noise Zones, each with its own noise standard for specified days in the week and hours in the day. While Noise Zones and Noise Zone Standards are specified in the *Environment Protection Regulation 2005*, the boundaries of Noise Zones are defined by maps within the Territory Plan.

The CCEP Core is an area within the CCEP supporting a clustering of higher noise emitting entertainment venues away from any currently constructed residential and commercial accommodation. The Frame makes up the remainder of the CCEP. The Frame contains a variety of venues which contribute to the entertainment scene, with existing residential and commercial accommodation developments within and adjacent to the CCEP Frame. The Frame supports entertainment uses while acting as a transition zone between the Core and the areas adjacent to the City Centre Entertainment Precinct.

Consultation about the night-time economy, which included proposed changes to the City Centre Entertainment Precinct Core and Frame Noise Zone Standards was undertaken in 2023 and early 2024.

The proposed changes are not inconsistent with section 84 (2) (d) of the Planning Act 2023.


### Minor Amendment 2024-e
