

Work Health and Safety (Working Safely with Asbestos Training Course and Occupations) Declaration 2025

Notifiable instrument NI2025-410

made under the

Work Health and Safety Regulation 2011, s 445A (Duty to train workers about working with asbestos)

1 Name of instrument

This instrument is the *Work Health and Safety (Working Safely with Asbestos Training Course and Occupations) Declaration 2025*.

2 Commencement

This instrument commences the day after it is notified.

3 Declared Occupations—Regulation, section 445A(2)(a)

Under the *Work Health and Safety Regulation 2011* section 445A(2)(a), I declare that a person in an occupation specified in column 2 of schedule 2 to this instrument is required to undertake the course declared under section 445A(2)(b).

4 Declared Working Safely with Asbestos Training Course—Regulation, section 445A(2)(b)

Under the *Work Health and Safety Regulation 2011* section 445A(2)(b), I declare the following course:

11348NAT – Course in Working Safely with Asbestos Containing Materials

5 Recognition of previous training

A person is not required to complete the course declared in section 3 of this instrument if:

- (a) they are required to be trained under section 445A of the *Work Health and Safety Regulation 2011*; and
- (b) have completed a course that has previously been declared in working safely with asbestos in occupations specified in Schedule 1 to this instrument.

5 Revocation

This instrument revokes the *Work Health and Safety (Working Safely with Asbestos Training Course and Occupations) Declaration 2020* [NI2020-530].
