1 Name of instrument

This instrument is the *Public Sector Management (Biosecurity) Delegation 2025 (No 2)*.

2 Commencement

This instrument commences on the day after its notification date.

3 Delegation of functions

I delegate my functions under the provisions of:

- (a) the *Biosecurity Act 2023* identified in schedule 1, columns 2 and 3 to the people who from time to time occupy the public service positions identified in the corresponding entry in schedule 1, column 4; and
- (b) the *Biosecurity (National Livestock Identification System) Regulation 2025* identified in schedule 2, columns 2 and 3, to the people who from time to time occupy the public service positions identified in the corresponding entry in schedule 2, column 4; and
- (c) the *Biosecurity Regulation 2025* identified in schedule 3, columns 2 and 3, to the people who from time to time occupy the public service positions identified in the corresponding entry in schedule 3, column 4.

Note: **Occupy** in relation to a position—see Legislation Act, dict, pt 1.

4 Revocation

This instrument revokes the *Public Sector Management (Biosecurity) Delegation 2025* (NI2025-215).
