

# Road Transport (Vehicle Registration) (Authorised Examiner Scheme Inspection Fees) Determination 2026 (No 1)

Notifiable instrument NI2026-196

made under the

**Road Transport (Vehicle Registration) Regulation 2000, section 153 (Minister may determine maximum fees for inspections)**

## 1 Name of instrument

This instrument is the *Road Transport (Vehicle Registration) (Authorised Examiner Scheme Inspection Fees) Determination 2026 (No 1)*.

## 2 Commencement

This instrument commences the day after its notification day.

## 3 Determination of fees

- (1) I determine this instrument applies to the inspecting or testing of a kind of vehicle mentioned in an item in column 2 of schedule 1 for the *Road Transport (Vehicle Registration) Regulation 2000*.
- (2) I determine the maximum fee payable to the proprietor of approved premises for inspecting or testing the vehicle is, if the inspection or testing occurs on or before 30 June 2026, the amount for that item in column 3.
- (3) I determine the maximum fee payable to the proprietor of approved premises for inspecting or testing the vehicle is, if the inspection or testing occurs on or after 1 July 2026, the amount for that item in column 4.

## 4 Payment of fees

A fee listed in schedule 1 is payable to the proprietor of premises approved under section 131 of the *Road Transport (Vehicle Registration) Regulation 2000* by a person requesting the inspection or testing of a motor vehicle or trailer for the purposes of that regulation.

## 5 Goods and services tax

Fees may be inclusive of GST, in accordance with the requirements of the *A New Tax System (Goods and Services Tax) Act 1999*.

## **6 Revocation**

This instrument revokes the *Road Transport (Vehicle Registration) Authorised Examiner Scheme Inspection Fees Determination 2025 (No 1)* (NI2025–262).
