## Regulations 1954. No. 6.

### Regulations under the Associations Incorporation Ordinance 1953.\*

I JOHN ARMSTRONG SPICER, the Attorney-General of the Commonwealth of Australia, in pursuance of the powers conferred on me by the *Associations Incorporation Ordinance 1953*, hereby make the following Regulations.

#### ASSOCIATIONS INCORPORATION REGULATIONS.

1. These Regulations may be cited as the Associations Incorporation Citation Regulations.

2.—(1.) In these Regulations, “the Ordinance” means the *Associations Incorporation Ordinance 1953*. Interpretation.

(2.) In these Regulations, a reference to a form by number shall be read as a reference to the form so numbered in the First Schedule to these Regulations.

3. The Registrar may refuse to accept an application, notice or other document which, under the Ordinance, is required to be filed or otherwise lodged with him— Requirements relating to documents.

- (a) if the document is not on foolscap paper with a margin at least two inches wide on the left hand side of each sheet; or
- (b) if the document has been, or appears to the Registrar to have been, altered in any particular.

4. A notice under section 3 of the Ordinance of intention to apply for the incorporation of an association under the Ordinance shall be in accordance with Form 1. Form of notice of intention to apply for incorporation.

5. A certificate of incorporation of an association issued by the Registrar under section 6 of the Ordinance shall be in accordance with Form 2. Form of certificates of incorporation.

6.—(1.) An application under sub-section (1.) of section 14 of the Ordinance for the issue to an incorporated association of a certificate of incorporation in a new name shall be in accordance with Form 3. Forms relating to changes of name.

(2.) A certificate of incorporation in a new name issued to an incorporated association by the Registrar under section 14 of the Ordinance shall be in accordance with Form 4.

Inspection of documents.

7.—(1.) The Registrar may permit a person to inspect all or any of the documents filed or otherwise lodged with the Registrar in respect of an incorporated association upon payment to the Registrar of—

- (a) a fee of Two shillings and sixpence in respect of each document to be inspected; or
- (b) a fee of Ten shillings,

whichever is the less.

(2.) At the request of a person made by post or otherwise, the Registrar may, upon payment to him of a fee of Ten shillings, furnish to that person any information in the Registrar's possession relating to an incorporated association.

Fees.

8. The fees set out in the Second Schedule to these Regulations shall, in respect of the matters to which they relate, be paid to the Registrar.
