## Regulations 1959. No. 23.

### Regulations under the *Rabbit Destruction Ordinance 1919-1959*.\*

I, GORDON FREETH, the Minister of State for the Interior, hereby make the following Regulations under the *Rabbit Destruction Ordinance 1919-1959*.

#### AMENDMENTS OF THE RABBIT DESTRUCTION REGULATIONS.†

1. Regulation 2 of the Rabbit Destruction Regulations is amended by Definitions. omitting the definitions of "Crown Land", "Director-General", "Holding", "Noxious Animal" and "Occupier".

2. Regulation 5 of the Rabbit Destruction Regulations is amended—  
(a) by omitting from sub-regulation (1.) the words "be made in accordance with Form 1 and shall"; and  
(b) by omitting sub-regulation (2.).

Forms of application for purchase or hire of wire netting, etc.

3. Regulations 6, 8, 9, 10, 11 and 12 of the Rabbit Destruction Regulations are repealed.

4. Regulations 13 and 14 of the Rabbit Destruction Regulations are repealed and the following Regulation is inserted in their stead:—

Prescribed notice under section 19.

"13. For the purposes of section 19 of the Ordinance, the prescribed notice is seven clear days' notice."

5. Regulation 15 of the Rabbit Destruction Regulations is amended by omitting the words "shall be made in accordance with Form 7, and with the application the applicant shall furnish" and inserting in their stead the words "shall be accompanied by".

Applications to group holdings—how made.

6. Regulations 16, 17, 18, 19 and 20 of the Rabbit Destruction Regulations are repealed.

7. Regulation 21 of the Rabbit Destruction Regulations is amended by omitting from sub-regulation (1.) the words "in accordance with Form 15".

Issue of licence

8. Regulation 25 of the Rabbit Destruction Regulations is amended by omitting the words "in accordance with Form 21".

Repeal.

9. Regulations 27 and 28 of the Rabbit Destruction Regulations are repealed.

Forms 1-21.

10. The Rabbit Destruction Regulations are amended by omitting Forms 1 to 21 (inclusive).
