

MOTOR VEHICLE (THIRD PARTY INSURANCE) REGULATIONS*

REGULATIONS 1968, No. 7†

1. Regulation 16 of the Motor Vehicle (Third Party Insurance) Regulations is amended— Premium rates.

- (a) by omitting from sub-regulation (2.) the words "Fifteen pounds twelve shillings" and inserting in their stead the words "Forty-six dollars and fifty cents"; and
- (b) by omitting from that sub-regulation the words "Forty-four pounds eighteen shillings" and inserting in their stead the words "One hundred and thirty-one dollars and twenty-five cents".

2. The First Schedule to the Motor Vehicle (Third Party Insurance) Regulations is amended by omitting Part II. and inserting in its stead the following Part:— Amendments of First Schedule.

- (a) by omitting from the column headed "Premium classification." in Form O the references to the classifications of premiums set out in that column;

- (b) by omitting sub-paragraph (a) of paragraph 1 of Form O;
 (c) by omitting from the column headed "Premium classification." in Form P the references to the classifications of premiums set out in that column; and
 (d) by omitting sub-paragraph (a) of paragraph 1 of Form P.

Amendments relating to decimal currency.

4. The Motor Vehicle (Third Party Insurance) Regulations are amended as set out in the First Schedule to these Regulations.

Amendments in relation to re-numbered sections of the Ordinance.

5. The Motor Vehicle (Third Party Insurance) Regulations are further amended as set out in the Second Schedule to these Regulations.

Application.

6. The amendments effected by these Regulations apply to and in relation to all policies, renewals of policies and certificates of insurance issued in respect of a period commencing on or after the first day of December, 1968.
