AMENDMENTS OF THE CANBERRA COMMUNITY HOSPITAL (CHARGES) **REGULATIONS†**

1. Regulation 1 of the Canberra Community Hospital (Charges) Regulations citation. is amended by omitting the words "Community Hospital" and substituting the word "Hospitals".

2. Regulation 5 of the Canberra Community Hospital (Charges) Regulations Classification is amended by omitting the words "of the Hospital as general wards" and sub-of wards. stituting the words " of a hospital as standard wards ".

3. Regulation 6 of the Canberra Community Hospital (Charges) Regulations Charges for is amended---in-patients.

- (a) by omitting from paragraph (a) of sub-regulation (1) the word "general" and substituting the word "standard"; and
- (b) by omitting from sub-regulation (2) the words "or of ambulance facilities ".

4. Regulation 11 of the Canberra Community Hospital (Charges) Regula- Charges where tions is amended by omitting sub-regulations (5), (6) and (7).

5. Regulations 12 and 13 of the Canberra Community Hospital (Charges) Regulations are repealed and the following regulation is substituted:-

"12. (1) The charge for lodging provided by the Board at the after-care Charges annex is Five dollars per week. for annex patients.

"(2) The charge for accommodation provided by the Board at the intellectually handicapped children's annex is Ten dollars fifty cents per week.".

6. The Canberra Community Hospital (Charges) Regulations are amended as The Schedule. set out in the Schedule.
