AMENDMENTS OF THE CANBERRA COMMUNITY HOSPITAL (CHARGES) REGULATIONS†

1. Regulation 1 of the Canberra Community Hospital (Charges) Regulations is amended by omitting the words "Community Hospital" and substituting the word "Hospitals". Citation.
2. Regulation 5 of the Canberra Community Hospital (Charges) Regulations is amended by omitting the words "of the Hospital as general wards" and substituting the words "of a hospital as standard wards". Classification of wards.
3. Regulation 6 of the Canberra Community Hospital (Charges) Regulations is amended— Charges for in-patients.
 - (a) by omitting from paragraph (a) of sub-regulation (1) the word "general" and substituting the word "standard"; and
 - (b) by omitting from sub-regulation (2) the words "or of ambulance facilities".
4. Regulation 11 of the Canberra Community Hospital (Charges) Regulations is amended by omitting sub-regulations (5), (6) and (7). Charges where patient entitled to compensation or damages.
5. Regulations 12 and 13 of the Canberra Community Hospital (Charges) Regulations are repealed and the following regulation is substituted:— Charges for annex patients.

"12. (1) The charge for lodging provided by the Board at the after-care annex is Five dollars per week.

"(2) The charge for accommodation provided by the Board at the intellectually handicapped children's annex is Ten dollars fifty cents per week."
6. The Canberra Community Hospital (Charges) Regulations are amended as set out in the Schedule. The Schedule.
