AMENDMENTS OF THE TAXI AND PRIVATE HIRE CAR REGULATIONS²

Taxi fares

1. Regulation 24 of the Taxi and Private Hire Car Regulations is amended—

- (a) by omitting from paragraph (3) (a) “37 cents” and substituting “40 cents”;
- (b) by omitting from paragraph (3) (b) “32 cents” and substituting “35 cents”;
- (c) by omitting from paragraph (3A) (a) “28 cents” and substituting “31 cents”;
- (d) by omitting from paragraph (3A) (b) “24 cents” and substituting “27 cents”;
- (e) by omitting from paragraph (4A) (a) “37” and substituting “40”; and
- (f) by omitting from paragraph (4A) (b) “42” and substituting “45”.
