Regulations 1987 No. 17¹

Taxi and Private Hire Car Regulations² (Amendment)

I, JOHN JOSEPH BROWN, the Minister of State for the Arts, Sport, the Environment, Tourism and Territories, hereby make the following Regulations under the *Motor Traffic Ordinance 1936*.

Principal Regulations

1. In these Regulations, “Principal Regulations” means the Taxi and Private Hire Car Regulations.

Interpretation

2. Regulation 4 of the Principal Regulations is amended by inserting in subregulation (1) the following definition in its appropriate alphabetical position:

“ ‘public holiday’ means a day that is observed as a public holiday in the Territory in accordance with the *Holidays Ordinance 1958*;”.

Taxi fares

3. Regulation 24 of the Principal Regulations is amended:

(a) by omitting subregulations (2) and (3) and substituting the following subregulation:

“(2) On a journey by a taxi, the flag-fall or hiring charge is:

- (a) if the journey commenced between 6 a.m. and 9 p.m. on any day other than a public holiday—\$1.50;
 - (b) if the journey commenced at any other time on any day other than a public holiday—\$2.40; or
 - (c) if the journey commenced at any time on a public holiday—\$2.40.”;
- (b) by omitting from subregulations (4) and (5) “, excluding the first kilometre,”; and
- (c) by omitting from subregulation (10) “50” and substituting “60”.

Schedule

4. Schedule 2 to the Principal Regulations is repealed and the following Schedule substituted:

Regulation 26

TAXI FARES

FLAG-FALL:

1.	For journey commencing between 6 a.m. and 9 p.m. on any day other than a public holiday	\$1.50
2.	For journey commencing at any other time on any day other than a public holiday	\$2.40
3.	For journey commencing at any time on a public holiday	\$2.40

RADIO BOOKING 60 cents

KILOMETRE RATES:

1.	Single hiring	60 cents
2.	Multiple hiring	45 cents
