Principal Regulations

1. In these Regulations, “Principal Regulations” means the Taxi and Private Hire Car Regulations.

Taxi fares

2. Regulation 24 of the Principal Regulations is amended—
- (a) by omitting from paragraph (2) (a) “\$2.00” and substituting “\$2.20”;
 - (b) by omitting from paragraph (2) (b) “\$1.50” and substituting “\$1.60”;
 - (c) by omitting from paragraph (3) (a) “65 cents” and substituting “70 cents”;
 - (d) by omitting from paragraph (3) (b) “48.75 cents” and substituting “52.50 cents”;
 - (e) by omitting from paragraph (4) (c) “75 cents” and substituting “81 cents”;
 - (f) by omitting from paragraph (4) (d) “56.25 cents” and substituting “60.75 cents”; and
 - (g) by omitting from subregulation (6) “\$17.50” and substituting “\$18.60”.
