## **Workers' Compensation Regulations<sup>2</sup> (Amendment)**

**Commencement**

1. (1) This regulation and regulation 2 commence on the day on which these Regulations are notified in the *Gazette*.

(2) The remaining provisions commence on the day on which section 5 of the *Workers' Compensation (Amendment) Act 1991* commences.

**Principal Regulations**

2. In these Regulations, "Principal Regulations" means the Workmen's Compensation Regulations.

**Citation**

3. Regulation 1 of the Principal Regulations is amended by omitting "Workmen's" and substituting "Workers'".

**Interpretation**

4. Regulation 2 of the Principal Regulations is amended by omitting from subregulation (2) "*Workmen's*" and substituting "*Workers'*".

**Claim by worker**

5. Regulation 3 of the Principal Regulations is amended—

- (a) by omitting "workman" and substituting "worker"; and
- (b) by omitting "under the Act".

**Claim by dependant**

6. Regulation 4 of the Principal Regulations is amended by omitting "under the Act".

**Frequency of medical examinations**

7. Regulation 7 of the Principal Regulations is amended—

- (a) by omitting "workman" and substituting "worker";
- (b) by inserting "or herself" after "himself"; and
- (c) by omitting "paragraph 10 of the First Schedule" and substituting "clause 10 of Schedule 1".

**Repeal**

8. Regulations 8, 9 and 11 are repealed.

**Witnesses to declarations**

9. Regulation 12 of the Principal Regulations is amended by omitting "legally qualified".

**Schedule 1**

10. Schedule 1 to the Principal Regulations is amended as set out in the Schedule.

**SCHEDULE**  
**AMENDMENT OF FORMS**

Regulation 10

**Form 1—**

- (a) Omit “*Workmen’s*” (wherever occurring), substitute “*Workers’*”.
- (b) Omit “WORKMAN”, substitute “WORKER”.
- (c) Omit “sixteen years”, substitute “16, or any dependent children between the ages of 16 and 25 who are full-time students”.
- (d) Omit “employee”, substitute “worker”.
- (e) Omit “workman”, substitute “worker”.
- (f) Omit “legally qualified”.
- (g) After “he” insert “or she”.

**Form 2—**

- (a) Omit “*Workmen’s*” (wherever occurring), substitute “*Workers’*”.
- (b) Omit “WORKMAN”, substitute “WORKER”.
- (c) Omit “*employee*”, substitute “*worker*”.
- (d) Omit “workman” (wherever occurring), substitute “worker”.
- (e) After “his” (wherever occurring), insert “or her”.
- (f) After “he” (wherever occurring), insert “or she”.
- (g) Omit “legally qualified”.

**Form 3—**

- (a) Omit “*Workmen’s*” (wherever occurring), substitute “*Workers’*”.
- (b) After “his”, insert “or her”.
