### **Commencement**

1. These Regulations commence on 1 July 1995.

### Principal Regulations

2. In these Regulations, “Principal Regulations” means the Motor Vehicle (Third Party Insurance) Regulations.

### Premium rates

3. Regulation 16 of the Principal Regulations is amended by omitting from subregulation (2) “\$89” and substituting “\$126”.

### Schedule 1

4. Schedule 1 to the Principal Regulations is amended by omitting Part II and substituting the following Part:
