Commencement

1. These Regulations commence on 1 July 1996.

Principal Regulations

2. In these Regulations, “Principal Regulations” means the Motor Vehicle (Third Party Insurance) Regulations.

Premium rates

3. Regulation 16 of the Principal Regulations is amended by omitting from subregulation (2) “\$126” and substituting “\$107”.

4. Schedule 1 to the Principal Regulations is amended by omitting Part II and substituting the following Part:
