# About this republication

### The republished law

This is a republication of the *Crimes (Sentence Administration) Regulation 2006*, made under the *Crimes (Sentence Administration) Act 2005* (including any amendment made under the *Legislation Act 2001*, part 11.3 (Editorial changes)) as in force on 22 September 2023. It also includes any commencement, amendment, repeal or expiry affecting this republished law to 22 September 2023.

The legislation history and amendment history of the republished law are set out in endnotes 3 and 4.

### Kinds of republications

The Parliamentary Counsel's Office prepares 2 kinds of republications of ACT laws (see the ACT legislation register at www.legislation.act.gov.au):

- authorised republications to which the *Legislation Act 2001* applies
- unauthorised republications.

The status of this republication appears on the bottom of each page.

### **Editorial changes**

The *Legislation Act 2001*, part 11.3 authorises the Parliamentary Counsel to make editorial amendments and other changes of a formal nature when preparing a law for republication. Editorial changes do not change the effect of the law, but have effect as if they had been made by an Act commencing on the republication date (see *Legislation Act 2001*, s 115 and s 117). The changes are made if the Parliamentary Counsel considers they are desirable to bring the law into line, or more closely into line, with current legislative drafting practice.

This republication includes amendments made under part 11.3 (see endnote 1).

### **Uncommenced provisions and amendments**

If a provision of the republished law has not commenced, the symbol  $\bigcup$  appears immediately before the provision heading. Any uncommenced amendments that affect this republished law are accessible on the ACT legislation register (www.legislation.act.gov.au). For more information, see the home page for this law on the register.

### **Modifications**

# 1 Name of regulation

This regulation is the *Crimes* (Sentence Administration) Regulation 2006.

# 2 Dictionary

The dictionary at the end of this regulation is part of this regulation.

Note 1 The dictionary at the end of this regulation defines certain terms used in this regulation, and includes references (*signpost definitions*) to other terms defined elsewhere.

For example, the signpost definition 'medicine—see the Medicines, Poisons and Therapeutic Goods Act 2008, section 11.' means that the term 'medicine' is defined in that section and the definition applies to this regulation.

Note 2 A definition in the dictionary (including a signpost definition) applies to the entire regulation unless the definition, or another provision of the regulation, provides otherwise or the contrary intention otherwise appears (see Legislation Act, s 155 and s 156 (1)).

### 3 Notes

A note included in this regulation is explanatory and is not part of this regulation.

*Note* See the Legislation Act, s 127 (1), (4) and (5) for the legal status of notes.

# 4 Parole order—core conditions—Act, s 137 (1) (f)

The following conditions are prescribed:

- (a) the offender must live only at premises approved by the director-general;
- (b) the offender must report to a person at a time and place nominated by the director-general;
- (c) the offender must not use a prohibited substance, or abuse a medicine that is lawfully obtained;

- (d) the offender must authorise each doctor, therapist or counsellor of the offender to give information about the offender to the chief executive;
- (e) the offender must not leave the ACT for longer than 1 day without the prior written permission of the director-general;
- (f) the offender must comply with all conditions to which a permission to leave the ACT is subject;
- (g) the offender must not leave Australia without the board's prior written permission;
- (h) the offender must not have possession or control of a firearm, prohibited weapon, prohibited article or offensive weapon;
- (i) the offender must comply with any direction given to the offender by the director-general.

### Example for par (b)

to report to a corrections officer at a correctional centre, or to a person where the offender works

### Examples for par (i)

directions about any of the following:

- associating with particular people
- visiting any place, including a particular suburb
- obtaining, being available for or keeping employment
- attending or taking part in an approved activity or program

# 5 Community-based sentence transfer—participating jurisdictions—Act, s 265 (3)

Each State is declared to be a participating jurisdiction.

Note State includes the Northern Territory (see Legislation Act, dict, pt 1).
