**1 Name of regulation**

This regulation is the *Road Transport (Third-Party Insurance) Amendment Regulation 2009 (No 1)*.

**2 Commencement**

This regulation commences on the day after its notification day.

*Note* The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

This regulation amends the *Road Transport (Third-Party Insurance) Regulation 2008*.
