1 Name of regulation

This regulation is the *Radiation Protection (Solariums Prohibition) Amendment Regulation 2013 (No 1).*

2 Commencement

This regulation commences on 31 December 2014.

Note The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

- *Note 2* For example, the Legislation Act, dict, pt 1, defines the following term:
 - Minister (see s 162).
- Note 3 Terms used in this regulation have the same meaning that they have in the *Radiation Protection Act 2006* (see Legislation Act, s 148). For example, the following terms are defined in the *Radiation Protection Act 2006*, dict:
 - national directory
 - radiation apparatus (see s 9 (3))
 - radiation source (see s 9 (1))
 - regulated radiation source (see s 10).

exempt radiation source means a radiation source that is exempt under—

- (a) the Act, section 114; or
- (b) section 9.

prohibited radiation source—see section 5.

solarium means a commercial establishment containing 1 or more tanning units to provide a service of tanning human skin for cosmetic purposes.

tanning unit means an electrically powered appliance or installation intended to produce tanning of the human skin by utilizing ultraviolet radiation.
