1 Name of regulation

This regulation is the *Family Violence (Transitional Provisions)* Regulation 2017.

2 Commencement

This regulation commences on the commencement of the *Family Violence Act 2016*, section 115 (Definitions—pt 9).

Note The naming and commencement provisions automatically commence on the notification day (see Legislation Act, s 75 (1)).

3 Modification of Act, pt 20—Act, s 201 (2)

The Act, part 20 is modified by schedule 1.

4 Expiry

This regulation expires on the day before a regulation for the Act, section 115, definition of *corresponding law*, commences.
