4	1 July 1932	<b>Court of Petty Sessions Rules (repealed)</b> (renamed as <b>Magistrates Court Rules 1932</b> ) made under the <i>Court of Petty Sessions Ordinance (No 2) 1930</i> (renamed as <i>Magistrates Court Act 1930</i> ) notified 7 July 1932 (Cwlth Gaz 1932 No 54) commenced 7 July 1932 (see <i>Interpretation Ordinance 1914 s 5</i> )	Rules expired 1 July 2006 (see A2004-59, s 100), but until 1 January 2007 continued to apply for the purpose of proceedings in the Magistrates Court as if they had not expired (see SL2006-29 r 7010)
5	11 July 1932	<b>Amendment of the Companies Regulations (repealed)</b> made under the <i>Companies Ordinance 1931</i> continued in force under the <i>Companies Ordinance 1954</i> notified 21 July 1932 (Cwlth Gaz 1932 No 56) commenced 21 July 1932 (see <i>Interpretation Ordinance 1914 s 5</i> )	lapsed on repeal of Ordinance 1 July 1962

11	21 December 1932	<b>Amendment of Regulations under Police Ordinance 1927 (repealed)</b> made under the <i>Police Ordinance 1927</i> notified 5 January 1933 (Cwlth Gaz 1933 No 1) commenced 5 January 1933 (see <i>Interpretation Ordinance 1914 s 5</i> )	lapsed on repeal of Act 1 December 1994
