<b>4</b>	<p><b>Police Regulations (repealed)</b> made under the <i>Police Ordinance 1927</i> notified 27 August 1964 (Cwlth Gaz 1964 No 71) commenced 27 August 1964 (see <i>Interpretation Ordinance 1937 s 16</i>)</p>	repealed by SL1980-3 sch 25 March 1980
<b>5</b>	<p><b>Canberra Community Hospital (Charges) Regulations (repealed)</b> made under the <i>Canberra Community Hospital Ordinance 1938</i> (renamed as <i>Canberra Hospitals Ordinance 1938</i>) notified 17 September 1964 (Cwlth Gaz 1964 No 78) commenced 17 September 1964 (see <i>Interpretation Ordinance 1937 s 16</i>)</p>	lapsed on repeal of Ordinance 1 July 1975
<b>6</b>	<p><b>Motor Vehicle (Third Party Insurance) Regulations (repealed)</b> made under the <i>Motor Traffic Ordinance 1936</i> notified 23 September 1964 (Cwlth Gaz 1964 No 79A) commenced 23 September 1964 (see <i>Interpretation Ordinance 1937 s 16</i>)</p>	repealed by A1999-79 sch 2 1 March 2000
<b>7</b>	<p><b>Commonwealth Motor Omnibus Fares Regulations (repealed)</b> made under the <i>Commonwealth Motor Omnibus Services Ordinance 1955</i> (renamed as <i>Motor Omnibus Services Act 1955</i>) notified 19 November 1964 (Cwlth Gaz 1964 No 94) commenced 19 November 1964 (see <i>Interpretation Ordinance 1937 s 16</i>)</p>	repealed by SL1986-14 22 August 1986
<b>8</b>	<p><b>Public Health (Dairy) Regulations (repealed)</b> made under the <i>Public Health Ordinance 1928</i> continued in force under the <i>Public Health Act 1997</i> notified 23 December 1964 (Cwlth Gaz 1964 No 101) commenced 23 December 1964 (see <i>Interpretation Ordinance 1937 s 16</i>)</p>	repealed by SL2000-1 sch 2 15 January 2000
